The Queen's Prison Law Clinic (QPLC) provides legal services to clients in Kingston-area prisons, and Warkworth Institution near Campbellford.

WHAT WE DO:

The Queen's Prison Law Clinic provides legal advice, assistance and representation in all aspects of prison law to prisoners:

- Represent clients at Disciplinary Court hearings
- Represent clients at hearings before the Parole Board of Canada
- Draft grievances
- Provide legal opinions
- Conduct meetings with inmate groups at Kingston-area penitentiaries
- Conduct test case litigation

WHO WE HELP:

Our services are available to our clients who meet Legal Aid Ontario's financial eligibility criteria and are incarcerated at one of the following institutions: Warkworth, Joyceville Institution-Medium, Joyceville Institution-Minimum, Bath Institution, Millhaven Institution, Collins Bay Institution-Maximum, Collins Bay Institution-Medium, and Collins Bay Institution-Minimum.

ABOUT THE QUEEN'S PRISON LAW CLINIC (QPLC)

The Queen's Prison Law Clinic provides legal advice, assistance, and representation in matters relating to prison and parole in Kingston-area penitentiaries and Warkworth Institution.

Most legal services are provided to clients by students under the supervision of the clinic's lawyers, as part of their legal education. Students learn to manage the solicitor/client relationship, interview clients, conduct case-specific research, prepare examinations/cross-examinations of witnesses, draft legal submissions, and represent clients at hearings.

The Queen's Prison Law Clinic is funded by Legal Aid Ontario.
